**Travel Documentation:** Because there are no foreign ports on your Hawaiian Inter-Island cruise, United States citizens are not required to have a passport, but are required to carry a valid Government-issued photo I.D. Proper travel documentation is required at embarkation and throughout the cruise. Even though a guest has completed the cruise line pre-cruise registration, it is still the responsibility of the guest to bring all required travel documents. Any guest without proper documents will not be allowed to board the vessel and no refund of the cruise fare will be issued.

**Deposits and Final Payment:** A \$250 per person deposit is due at the time of making reservation. **Final Payment will be due March 11, 2013.** Please make sure that I receive your final payment by the due date. Norwegian Cruise Line now has an automated computer system that CANCELS any booking not paid by final payment date.

**Cancellation Policy:** All cancellations must be made in writing. Faxes (210-688-9397) are accepted. We will notify you when we receive your written cancellation. If you do not receive notice from us (Travel By Jeffrey) please contact us to confirm receipt of your notice. Travel By Jeffrey will charge a \$50 per person administrative fee in addition to any cancellation penalties the cruise line, airline, tour operator charges.

**Cruise Cancellation Policy:** If a reservation must be cancelled, the following penalties will be incurred per person:

75 – 56 days prior to departure date	Deposit	29 – 15 days prior to departure date	75% of cruise fare
55 – 30 days prior to departure date	50% of cruise fare	14 days prior to departure date or less	100% of cruise fare

Suites and Villas have a different cancellation policy. If you are booked in one of these staterooms the cruise cancellation policy will be printed on your invoice.
